- When installed, all new skirting boards require gap-filling and painting after installation. This service is not apart of our quote and must be organised through separate qualified tradespeople.

- You acknowledge that the extent of surface preparation included in the scope of the Works is limited to sanding or scraping to the previous coat (if applicable) and filling minor surface depressions to create a flush surface. Unless specifically stated in the description of the Works in the Quotation Form, the Works exclude rectification of faults or defects in the building structure or substrate condition, delaminating previous coatings and repairs or replacement (in whole or in part) of existing substrate surfaces.
